## Expect Delays due to Reduced Lanes and No Street Parking (Temporary)

Dear Neighbors:

The City of Santa Monica hired Excel Paving to renew the pavement surface of **Wilshire Boulevard from Ocean Avenue to 17<sup>th</sup> St.** Work is scheduled **starting Monday, May 8th through Friday, May 12th, 2023**. The contractor will grind out the top 2- 3-inch layer of the existing street and repave with new asphalt pavement. There will be temporary traffic and street parking closures. The operation of heavy equipment will be necessary to repave the street and there will be periods of intermittent loud noise during the construction. **Paving work for Wilshire Blvd. between 17<sup>th</sup> St. and Centinela Ave. is expected to start on a date yet to be determined.** The City appreciates your patience during these capital improvement projects.

- > One lane of through traffic in each direction will remain open during construction.
- > Temporary lane closures will be in effect Monday through Friday.
- Street parking on Wilshire Blvd. will NOT be allowed during the paving of street.
- > Parking restrictions (temporary no parking signs) in the area will be posted accordingly in the work areas affected.
- > Driveway access will be limited for entry or exit during the lane closures but will be allowed.
- > The paving work will be a moving operation where lanes will be temporarily closed while crews are working at a location.
- > After paving is completed, the roadway will be tabbed with temporary safety markers to indicate lane locations.
- > After the asphalt has dried for approximately 1-2 weeks, permanent roadway markings will be installed.

Thank you in advance for your patience and cooperation. The City understands this process is inconvenient and staff will make every effort to minimize the disruption. Please contact Fabio M. Should the schedule change, temporary "NO PARKING" signs with revised dates will be posted.

The enhancements to Wilshire Boulevard are part of a comprehensive initiative to enhance the safety and accessibility for pedestrians, bicyclists, and public transit riders. The improvements were developed through the Wilshire Safety Study, which evaluated the 2.4-mile corridor using a combination of community feedback and crash data analysis to determine the most effective and high-impact approach to enhancing transportation safety and transit service.
